Purpose of the processing

The processing of your personal data will be based on principles of fairness, lawfulness and transparency, to protect your privacy and your rights. The controller undertakes to process your data in compliance with the principle of "minimization", or by acquiring and processing data only for the following purposes:

- a) Management and execution of pre-contractual obligations or deriving from the task assigned by you.
- b) Management of tax and accounting obligations;
- c) Compliance with obligations under the law, regulations and EU legislation.
- d) Sending information and advertising material or for commercial communications regarding new products or updates and news on existing products.

These processing can only be carried out with your consent (Article 6.1 letter of the Regulation). This consent may be revoked at any time without prejudice to the lawfulness of the treatment based on the consent given before the revocation.

Processing methods

Data retention period

10 years from the moment of termination of the contract

Rights recognized to the Data Subject party

At any time, you can exercise, towards the Data Controller, your rights under Articles 15-22 of the Regulation. In particular, at any time, you will have the right to ask:

- access to your personal data;
- your rectification in case of inaccuracy;
- cancellation and deletion;
- the limitation of your processing

You will also have:

- the right to oppose your processing if you consider your fundamental rights and freedoms to be violated;
- the right to withdraw your consent at any time in relation to the purposes for which this is necessary;
- the right to the portability of your data, or the right to receive, in a structured format, commonly used and readable by automatic device, the personal data referred to you.
- the right not to be subjected to a decision based solely on automated processing, including profiling, which produces legal effects that affect you or which significantly affects your person.

Right to propose a complaint to the supervisory authority

Each Member State shall provide that one or more independent public authorities are responsible for monitoring the application of this Regulation in order to protect the fundamental rights and freedoms of natural persons about processing and to facilitate the free movement of personal data within EU (the 'supervisory authority') art. 51 of the Regulation.

Without prejudice to any other administrative or judicial remedy, the Data Subject who considers that the processing concerning him/her is in violation of this Regulation shall have the right to lodge a complaint with a supervisory authority, notably in the Member State in which he/she normally resides, works or the place where the alleged violation has occurred.
